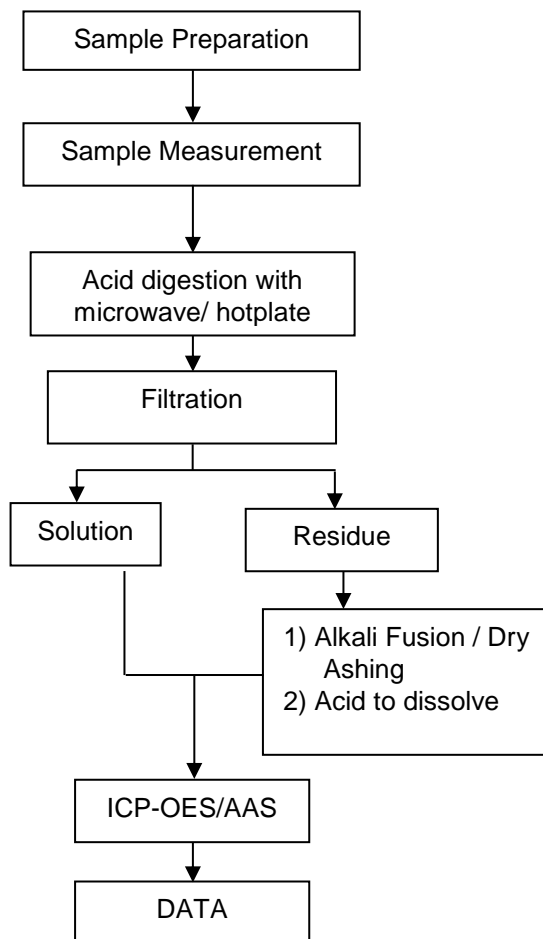

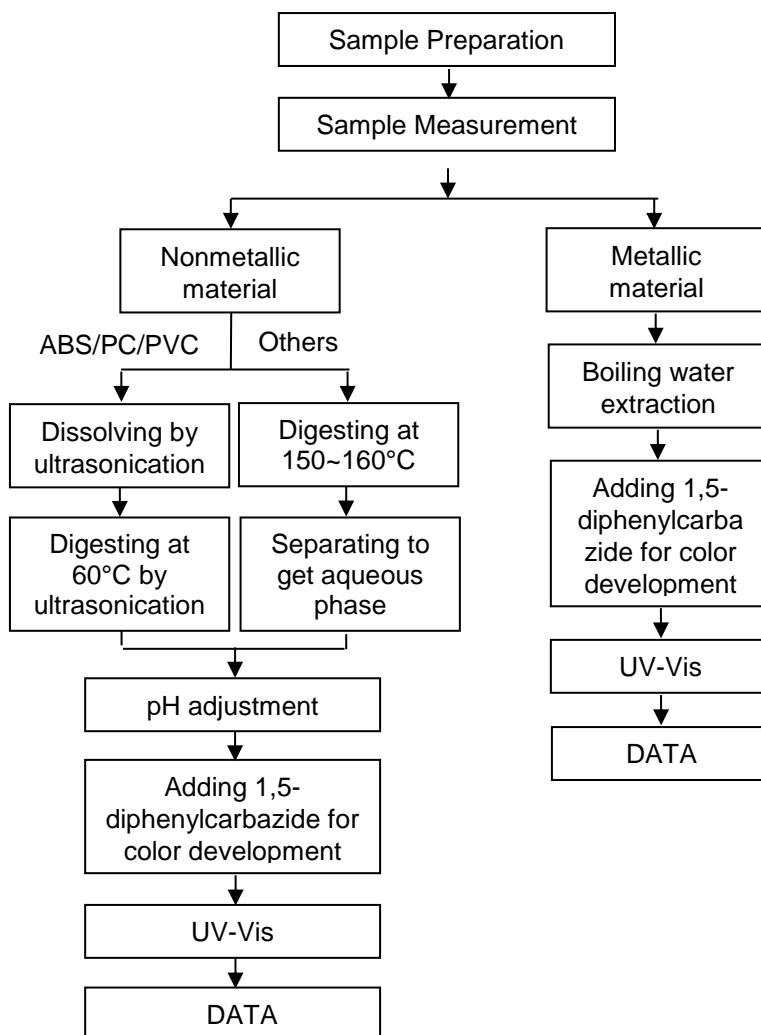

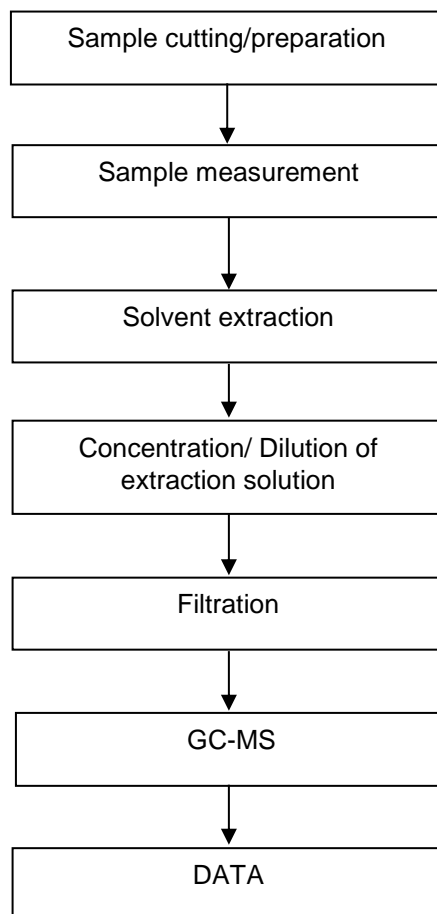

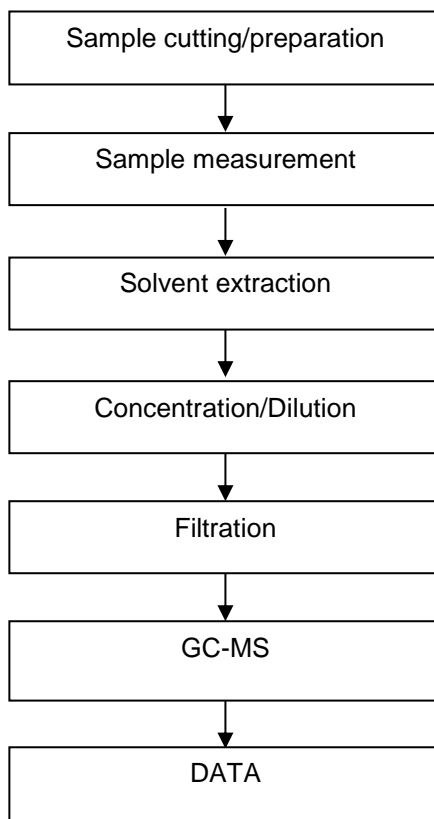

HBCDD Testing Flow Chart



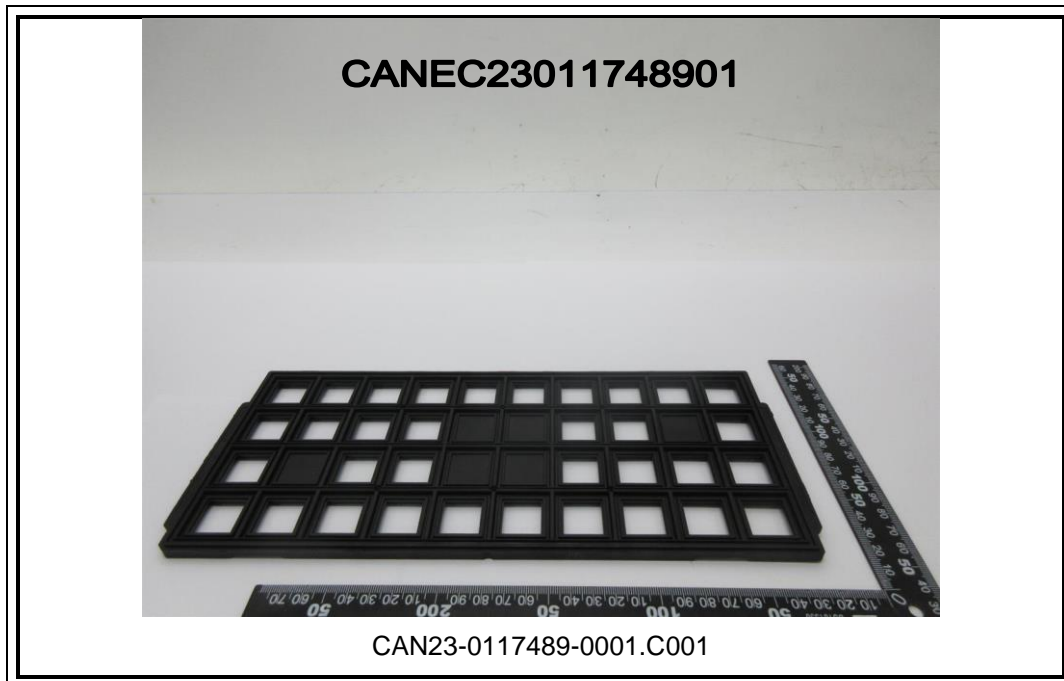
