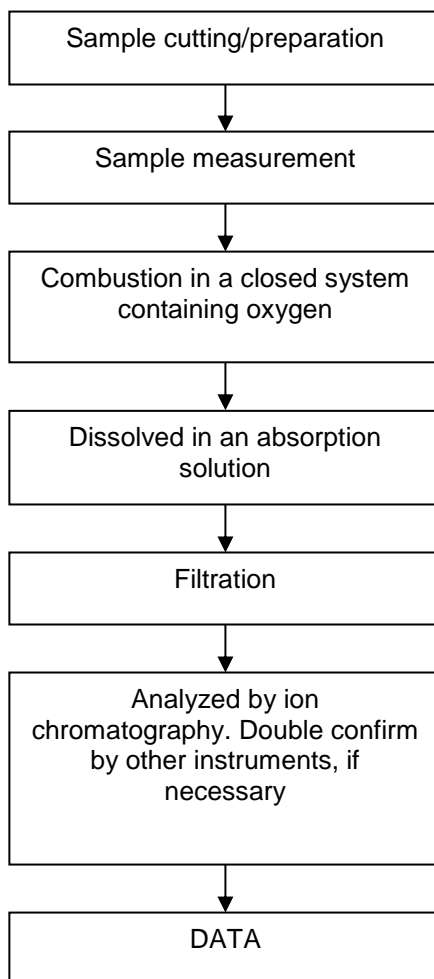

#### Halogen Testing Flow Chart



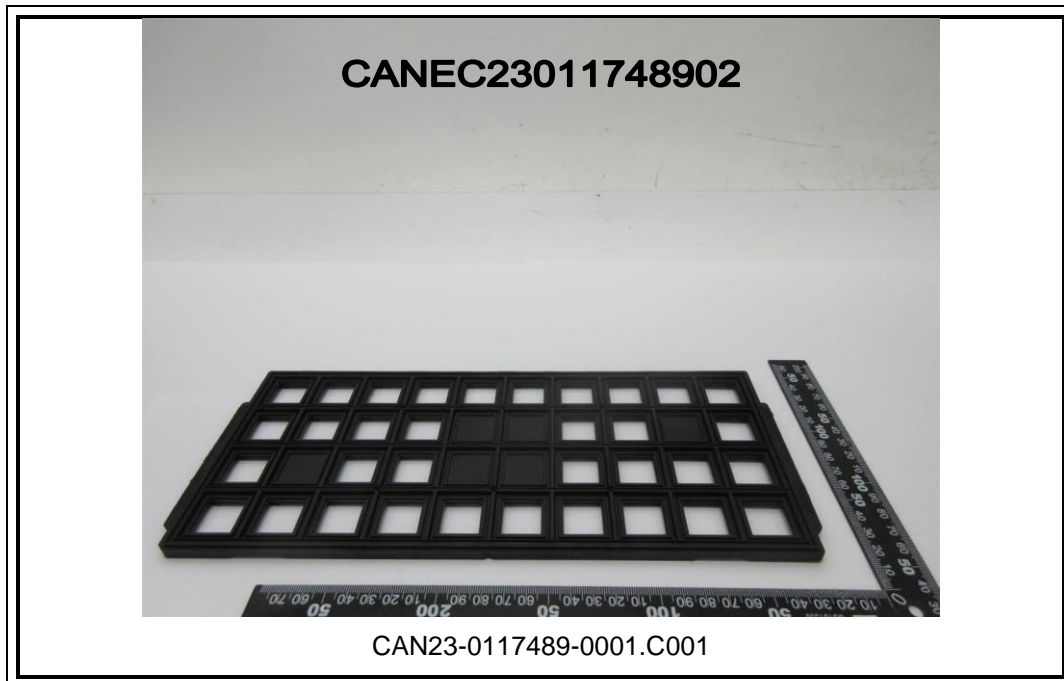
